#### National Action Plan for Tackling Child Sexual Exploitation

The national action plan for tackling child sexual exploitation, published on 23 November 2011, brings together for the first time actions by the Government and a range of national and local partners to protect children from this largely hidden form of child abuse.

Sexual exploitation of children and young people under 18 can involve gangs or individuals luring them into performing sexual activities in exchange for gifts like money, food, drugs or alcohol. It can also happen through grooming using technology - for example, young people being persuaded to post sexual images on the internet or mobile phones.

The action plan looks at sexual exploitation from the perspective of the child. It highlights areas where more needs to be done and sets out specific actions which government, local agencies and voluntary and community sector partners need to take to address this horrific form of abuse.

#### Headline News Children, Young People and Families

The Chancellor made his autumn statement on Tuesday. Some key announcements for children, young people and families:

- The planned £110 above inflation increase to the child element of the Child Tax Credit will not be implemented and the couple and lone parent elements of the Working Tax Credit in 2012–13 will not be uprated,
- There will be an extra £600 million to fund 100 additional Free Schools by the end of this Parliament. This will include new specialist maths Free Schools for 16-18 year olds, supported by strong university maths departments and academics,
- An additional £600 million will support those local authorities with the greatest demographic pressures. This funding is enough to deliver an additional 40,000 school places.
- A Youth Contract worth a total of £940 million over the Spending Review 2010 period. The government will fund wage incentives for 160,000 young people to make it easier for private sector employers to take them on,
- A further £380 million a year by 2014–15 to extend the offer of 15 hours free education and care a week for disadvantaged two year olds, covering an extra 130,000 children.

#### **Youth Contract**

Deputy Prime Minister Nick Clegg has outlined a £1 billion pound Youth Contract to tackle youth unemployment.

The Deputy Prime Minister Nick Clegg said:

"The aim of the Youth Contract is to get every unemployed young person working or learning again before long term damage is done. This is a £1bn package and what's different about it is gets young people into proper, lasting jobs in the private sector. But it's a contract, a two-way street: if you sign up for the job, they'll be no signing on for the dole. You have to stick with it"

#### **Headline News Youth Contract**

- Over three years, the Youth Contract will provide at least 410,000 new work places for 18 to 24 year olds into work. Starting next April.
- Including 160,000 wage subsidies and 250,000 new work experience placements.
- In addition, there will be at least 20,000 more incentive payments to encourage employers to take on young apprentices.

#### **Policy Detail**

- All figures refer to the three year period from April 2012 and are in addition to existing support.
- The Youth Contract is open to all businesses, including those that already employ large numbers of young people (like retail and construction) and emerging sectors (like the green economy, creative industries and ICT).
- 160,000 18 to 24 year olds to be taken on by employers using wage incentives
- A work experience place for every unemployed 18 to 24 year old who wants one (after they have been on JSA for 3 months) before they enter the Work Programme.
- More funding to support the growth in apprenticeships for 16 to 24 year olds
- A new £50m programme for persistently NEET 16 and 17 year olds to get them learning, on an apprenticeship or in a job with training.
