Risk assessments

- Government guidance refers people back to the Health and Safety Executive advice on risk assessments, https://www.hse.gov.uk/simple-health-safety/risk/risk-assessment-template-and-examples.htm
- The HSE also has this information regarding making your workplace Covid secure, https://www.hse.gov.uk/coronavirus/working-safely/index.htm
- It's important to ensure that staff and volunteers are considered in any decision to re-open community buildings as trustees also have a responsibility to ensure their safety. It's good practice to talk to your teams regularly to determine any particular concerns they may have about opening so these can be mitigated before you open.
- No centre should re-open if they cannot ensure the safety of staff, volunteers and public using the building, regardless of the requests from outside parties for buildings to open.

Numbers of people in a room





- This will depend on a number of factors.
- First and foremost, your own covid risk assessment for your building, and each room within the building. Bear in mind too any public areas, entrances, access to the building etc etc. See above for the section on risk assessments.
- Any staff that need to be in attendance don't count towards any limits so for a wedding, the person conducting the service can be in addition to the 15 people allowed.
- Some activities such as 'Drop-ins' are fine in a Covid secure environment (provided there is enough space for social distancing and face, hands and cleaning regime principles are followed). Numbers can be 6 or more *if it is for a 'support group' rather than a 'social group'.

Policing compliance

Who ensures users of a building comply with the legislation, and any local rules in place to ensure safe operation of a building?

The guidance on the safe operating of community venues states that "Anyone with control of non-domestic premises must take reasonable measures to ensure the premises are safe for people using it, so far as is reasonable practical." It goes on to state that "users and hirers of a community facility have responsibility for managing risks arising from their own activities when they have control of premises..." So, the trustees need to ensure they have done everything they can to ensure safe operation, and that this is communicated clearly to anyone hiring or using the premises. Once this is done, then the hirer is responsible for ensuring compliance.
