

By becoming a member of Macc you will gain access to our free funding portal of funding opportunities. Please note: To be eligible to access our



funding portal you must be a VCSE organisation working in the City of Manchester with at least 50% of your beneficiaries in the City of Manchester. VCSE organisations working outside of the City of Manchester, consultants, sole traders, statutory bodies, private businesses and infrastructure organisations who become members of Macc aren't eligible to access our funding portal. <b>Aims/priorities:</b>	<p>Financial support in the form of grants is available to registered charities, CIC's and voluntary organisations. The Charity Service are keen to support organisations that are working 'on the ground' directly supporting disadvantaged people within the Greater Manchester area. Grant funds are available for:</p> <ul style="list-style-type: none"> <li>• the purchase or supply of activities, amenities or equipment that will improve the general welfare of the local community or an individual</li> <li>• the purchase or supply of activities, amenities or items of a medical nature NOT supplied by the NHS</li> <li>• new project costs (for a specific period)</li> <li>• any other charitable purpose that has a direct impact on the welfare of the local community or an individual</li> <li>• holidays or days out to visit an attraction for children who are disadvantaged, disabled, sick and/or convalescent whose</li> </ul>	


	family are unable to afford the cost (referral must be via a supporting agency)
<b>Who can apply?</b>	Registered charities, CIC's and voluntary organisations
<b>Grant amount:</b>	Grants applications for funding will be assessed on the proposed impact, outcomes and budgetary detail. Grants applications of £5,000 or more (up to a maximum of £10,000) will require a greater level of scrutiny at the application stage and, if successful, monitoring by The Charity Service will be required.

### Manchester Wellbeing Fund



<b>Aims/priorities:</b>	A budget of £1.5m has been allocated for the three-year Manchester Wellbeing Fund, for community groups and GMMH service users who have great ideas about how to support their communities. The main objectives of the Fund are: <ul style="list-style-type: none"> <li>• To develop community support around people's mental health needs</li> <li>• To promote mental health and wellbeing</li> <li>• To challenge the stigma around mental illness</li> </ul>
<b>Who can apply?</b>	The Fund is for groups and service users who are passionate about mental wellbeing in their communities. It is designed to support individual projects rather than provide core funding for organisations.

<b>Application process:</b>	Applicants need to first complete an online expression of interest form. For grants of up to £500 applicants will only have to submit an expression of interest form.

<b>Aims/priorities:</b>	Neighbourhood Investment Funds are available to communities to make their neighbourhoods better places to live. £20,000 of neighbourhood investment funding is available to every area (ward) in Manchester each year – to help groups carry out events and activities that benefit people in their local neighbourhood.	
<b>Who can apply?</b>	The fund is open to established groups, voluntary groups and other community groups, as well as groups of residents working together for the first time. School Parent Teacher Associations can also apply if they have the support of local residents and parents and the project benefits the wider community as well as the school.	
<b>Grant amount:</b>	Applications should not exceed £10,000	
<b>Application process:</b>	There is an online application form	
<b>Deadline:</b>	Applications can be submitted at any time

<b>Aims/priorities:</b>	<p>Funding is available for small-scale arts and/or community and social welfare projects in England and Wales. The Foundation favours revenue proposals over capital requests and focuses its funding on the following main themes:</p> <ul style="list-style-type: none"> <li>• Rural</li> <li>• Arts</li> <li>• Community</li> <li>• Small charities</li> <li>• Wales</li> </ul>
<b>Who can apply?</b>	<p>Applications are accepted from UK registered charities and exempt charities. Other not-for-profit organisations, including unregistered charities, are also eligible to apply provided they are supported by a registered charity that can accept the grant on their behalf. It welcomes proposals from community museums, organisations, farms and gardens for funding for arts subjects.</p>
<b>Grant amount:</b>	<p>There is no set limit on the amount that can be awarded; however, preference is given to requests that are below £10,000. Funding is generally awarded to one-off projects although funding over a number of years (up to three) will be considered if the project requires it.</p>
<b>Application process:</b>	<p>There is an online application form</p>
<b>Deadline:</b>	<p>Applications can be made at any time and funding awards are made three times per year following the meeting of the Board of Trustees</p>

<b>Who can apply?</b>	<p>To be eligible, applicants must meet the following requirements:</p> <ul style="list-style-type: none"> <li>• Own or manage theatres with titles or signed leases of more than five years on buildings in England, Scotland, Wales or Northern Ireland</li> <li>• Demonstrate that they run a regular theatre programme of professional, community and/or amateur work presenting no less than 30 performances a year</li> <li>• Have a bona fide UK charitable or not-for-profit legal structure and be able to provide certified or audited accounts for at least two years</li> </ul>
