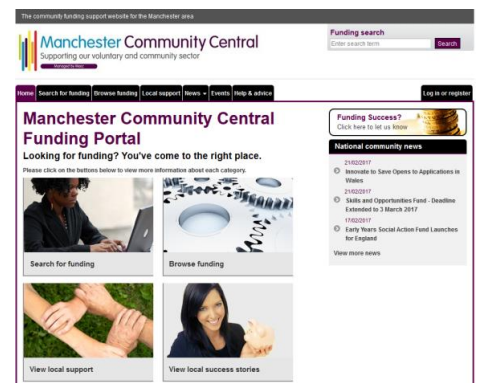

Please note: To be eligible to access our funding portal you must be a VCSE organisation working in the



City of Manchester with at least 50% of your beneficiaries in the City of Manchester. VCSE organisations working outside of the City of Manchester, consultants, sole traders, statutory bodies, private businesses and infrastructure organisations who become members of Macc aren't eligible to access our funding portal. COVID-19

Allchurches Trust – Hope Beyond

Aims/priorities: The aim of the Hope Beyond grants programme is to enable churches and Christian charities to meet changing needs within their communities as the longer-term impact of the coronavirus/Covid-19 crisis becomes clearer. The funding is for innovative, impactful projects that will enable people, organisations and communities to flourish in life after lockdown, building resilience and encouraging hope. Projects that address at least one of the following three key themes are eligible:



- Projects responding to the issues of loneliness and isolation exacerbated by the coronavirus/Covid-19 pandemic where new and/or enhanced support is being proposed. This

could include enabling improved accessibility to buildings/activities and measures to ensure buildings are coronavirus/Covid-19 safe

- Projects focused on growing community resilience and promoting mental and emotional health and wellbeing, including the provision of mental health and wellbeing support groups and 1:1 counselling for people of all ages.
- Projects focused on growing technological capability and resilience, particularly increasing digital capacity and provision, and supporting those without online access to get online through training and support

Who can apply? Churches, cathedrals, Christian denominational bodies and Christian charities.

Grant amount: Grants of up to £50,000 are available.

Application process: There is an online application form

Deadline: Applications will be accepted on a rolling basis until all the funding has been allocated

Alpkit – Go Nice Places, Do Good Things Grant

Aims/priorities: Alpkit welcome any applications from individuals or organisations serving those affected by coronavirus, across the country. Examples include:

- Being active in your local community to help elderly or vulnerable people
- Minimising the impact of self-isolation for those in quarantine and need access to food, medicines or social care
- Supporting foodbanks and increasing the number of meals on wheels deliveries to support the elderly
- Supporting those who are homeless or in temporary accommodation

Who can apply? Individuals or organisations

Grant amount: Grants of £500 are available

Arts Council England National Lottery Projects Grants

Aims/priorities: In response to the impact of the coronavirus/Covid-19 crisis on the sector, between July 2020 and April 2021 the programme will support individuals and organisations to get activities up and running again, and to help people take their first steps in getting re-engaged with culture and creativity.

Who can apply? Because of the circumstances during the coronavirus/Covid-19 crisis, the programme will be particularly keen to support:



- Applications from individual creative practitioners (including time to think and plan)
- Research and development activity
- Organisational development activity
- Live activity that can be safely delivered within this period (rather than activity with a start date far in the future)
- Activity that closely aligns with the Arts Council's equality objectives

Grant amount: Maximum value: £ 100,000 Minimum value: £ 1,000

Grants can support projects where the capital-specific expenditure in a project totals less than £100,000. This includes:

- Applications for capital work only, where that capital work will cost up to £100,000
- Applications for a mix of activities that include some capital spending where the total cost of the capital work is less than £100,000

BBC Children in Need Main Grant and Small Grant

Applications to reopen on 18th February 2021



Aims/priorities: All applications will have to show how this funding will

make a difference to children and young people's lives during this crisis. Due to the COVID-19 pandemic, the funder has temporarily broadened the types of applications it is accepting. Currently funding is being offered that can be used more flexibly than usual. Applications are encouraged for:

- Project delivery (Including staffing and salary costs)
- Creative solutions to deliver much needed services
- Organisational costs to support stability and adaptation. (Including the day-to-day running costs of an organisation as opposed to specific project costs)

Applications are not limited to one specific project and a request can be made for organisational running costs. The funder is committed to supporting voluntary groups with these types of grants.

Who can apply? Registered not-for-profit organisations that work with disadvantaged children and young people of 18 years and under who live in the UK, the Isle of Man or the Channel Islands.

Grant amount: Small grants: up to £10,000. Main grants: £10,001 - £40,000 per year for up to 3 years (but rarely more than £100,000 in total).

Application process: The application process requires that applicants register by submitting an Organisation Registration form. Once registered, organisations will receive a link to fill in a Main

Grants Project Application Form. This form can then be accessed through the online application portal. Registration is open all year-round, with cut-off dates for each application round. It is expected that decisions on Registration will take about three weeks.

Community Business Renewal Fund by Power to Change



Aims/priorities: The fund provides grants of between £10,000 and £20,000 to community businesses in England affected by the Covid-19 crisis to adapt, renew and rebuild their business so they can remain financially viable. The fund is aimed at organisations delivering services in their local community to support those who have been most affected by the Covid-19 crisis. The main priority support areas for the fund include: areas of England facing high levels of deprivation, organisations supporting and led by disabled people and Black, Asian and Minority Ethnic (BAME)-led or BAME-supporting businesses.

Who can apply? Community businesses

Grant amount: Between £10,000 and 20,000

Application process: Applicants first need to complete an online eligibility checker

Deadline: Short application window: 2 March 2021, 10am-1pm

Emergency Grants for Greater Manchester BAME Communities



Aims/priorities: The aim of the scheme is to support BAME led organisations in Greater Manchester by funding new activities and services as well as the additional costs of adapting existing services due to the coronavirus/Covid-19. The funding will also help counter the loss of fundraising income directly caused by the pandemic.

Who can apply? Grants are available for small BAME-led VCSE organisations in Greater Manchester affected by the Covid-19 pandemic, to enable them to respond to the needs of BAME communities.

Grant amount: Two levels of funding are available:

- Micro Grants of between £50 and £1,000

- Small Grants of between £1,000 and £5,000

Organisations can apply for both a Micro and Small Grant.

Application process: Guidelines are available on the website of GMCVO. Applications should be completed online, through the GMCVO grants portal. Organisations will need to register on the portal first before they can apply.

Deadline: Micro grants applications can be submitted at any time. Small Grants: 16 February 2021, 4pm

Heritage Recovery and Resilience Loans

Aims/priorities: Funding is available for not-for-profit organisations that are current or previous recipients of a grant directly from National Heritage



Lottery Fund to support activities and costs that will develop and restart their income generating potential. Heritage Recovery and Resilience Loans are long-term investment to support the actions needed to stabilise and modify operations, build organisational resilience, and adapt programmed projects as part of an organisation's recovery from the impact of coronavirus/Covid-19. This funding is well suited to organisations who have already been working on resilience, and are currently operating with a mixed income model of enterprise and grant funding, who require support to meet operating costs or adjust their operating model as a result of the Covid-19 crisis.

Who can apply? To be eligible, applicants must be a:

- Not-for-profit organisations
- Current or previous recipient of a grant directly from National Heritage Lottery Fund

Grant amount: Loans of between £50,000 and £250,000 are available

Application process: There is an online application form

Deadline: 14 February 2021. Decisions will be made by the end of March 2021.

LGBT+ Futures Fund



Aims/priorities: The aim of the Fund is to provide funding for LGBT+

organisations and projects to enable them to continue through the coronavirus/COVID-19 pandemic and meet the immediate needs of LGBT+ people and communities adversely affected by the pandemic. Grants will be awarded towards ongoing work, core costs and additional work which strengthens the position of organisations and their ability to respond to community needs at this

challenging time. Grants are for short-term work only and all funds awarded must be fully spent by 31 May 2021.

Who can apply? UK based non-profit groups and organisations that work with Lesbian, Gay, Bisexual and Trans + (LGBT+) people can apply.

Grant amount: Two levels of funding are available:

- Small grants of up to £5,000
- Main grants of between £5,001 and £15,000. Most grants will be for between £5,001 and £10,000 and larger grants will be exceptional

Each organisation can apply for one grant only – either a small or a main grant.

Application process: The funding will be awarded in tranches to ensure enough funding is carried forward to meet the needs of later applicants. Organisations will receive a decision within six weeks of receipt of application.

National Lottery Awards for All – England

Aims/priorities: The aim of the grants programme is to support communities to thrive by funding projects that:

- Build strong relationships in and across communities
- Improve the places and spaces that matter to communities
- Help more people to reach their potential, by supporting them at the earliest possible stage. During the ongoing coronavirus/Covid-19 pandemic, the Awards for All programme is supporting people and communities most adversely impacted by the crisis

Organisations can apply for funding to:

- Continue to deliver activity – whether the community needs crisis response, recovery or business as usual activity
- Change and adapt, becoming more resilient to respond to new and future challenges

Who can apply? Applications are accepted from voluntary, community and not for profit organisations, schools (for projects that benefit and involve the communities around the school), Statutory bodies (including local authorities, town, parish and community council) and Community benefit societies. To be eligible for funding applicants must have:

- Two unconnected people on the board or committee
- A UK bank account in the name of their organisation
- Annual accounts (unless the organisation is less than 15 months old)



The National Lottery Community Fund is 'keen' to support smaller organisations and will consider their income when making a decision.

Grant amount: Grants of between £300 and £10,000 are available for up to one year

National Lottery Community Fund – Partnerships



Aims/priorities: Grants are available to voluntary and community organisations in England which work together with a shared set of goals and values to help their community thrive. The aim of the programme is to encourage organisations to work in partnership to help their communities thrive by focusing on the bigger picture, rather than just what their organisation can do on its own. “Communities” can be people living in the same area, or people with similar interests or life experiences. The funding can support different types of partnership, including:

- Cross-sector partnerships
- Local place-based collaboration
- Local and national organisations working together around a particular theme

Who can apply? Applications are accepted from voluntary, community and not for profit organisations, schools (for projects that benefit and involve the communities around the school), Statutory bodies (including local authorities, town, parish and community council) and Community benefit societies.

Grant amount: Grants of over £10,000 are available for up to five years

Application process: Funding proposals can be submitted using the online application form or by sending an email or video to the relevant regional funding officer (details are on the National Lottery Community Fund website). The online application form can be found on the National Lottery Community Fund.

National Lottery Community Fund – Reaching Communities



Aims/priorities: The aim of the grants programme is to support communities to thrive by funding projects that:

- Build strong relationships in and across communities
- Improve the places and spaces that matter to communities
- Help more people to reach their potential, by supporting them at the earliest possible stage.
- During the ongoing coronavirus/COVID-19 pandemic, the Reaching Communities programme is supporting people and communities most adversely impacted by the crisis

Organisations can apply for funding to:

- Continue to deliver activity – whether the community needs crisis response, recovery or business as usual activity
- Change and adapt, becoming more resilient to respond to new and future challenges

Who can apply? Applications are accepted from voluntary, community and not for profit organisations, schools (for projects that benefit and involve the communities around the school), Statutory bodies (including local authorities, town, parish and community council) and Community benefit societies.

To be eligible for funding applicants must have:

- Two unconnected people on the board or committee
- A UK bank account in the name of their organisation
- Annual accounts (unless the organisation is less than 15 months old)

Grant amount: Grants of over £10,000 are available for up to five years.

Application process: There is an online application form or applicants can send an email or video to their regional funding officer (details are on the National Lottery Community Fund website).

Organisations will then be contacted by the National Lottery Community Fund within 12 weeks of submitting a proposal to discuss the next steps of the application process.

Resilience and Recovery Loan Fund

Aims/priorities: The fund aims to support social-sector organisations working to improve people's lives in the UK that are facing a problem

because expected income and activity has been delayed or disrupted as a result of the



coronavirus/Covid-19 pandemic. The scheme offers emergency loans that can be used as working capital until an organisation's normal business can commence again. Examples of how the loan funding could be used include:

- Providing a bridge until receiving government payments (e.g. contracts, furlough etc.)
- Covering a delay in trade payments (trade debtors)
- Supporting the rapid scaling up of an existing business model to meet an increased demand for services during the crisis
- Providing a bridge to cover revenue shortfall for proven and profitable trading activity

Who can apply? Applications are accepted from social-sector organisations that are improving people's lives across the UK and that meet the governance principles set out by Big Society Capital.

Grant amount: Loans of between £100,000 and £1.5 million are available for a term of one to five years. Loans will have no fees or interest for the first 12 months. After principal payments start the following interest rates will be applied: 6.5% p/a (from year two) for a loan term of 1-3 years; 7% p/a (from year two) for a loan term of more than 3 up to 5 years.

Aims/Priorities: The Covid-19 Emergency Fund has been set up by the Sylvia Waddilove Foundation to help small to medium sized organisations who are struggling to manage the financial impact of COVID-19 either because of increased demand for their services or loss of income. The fund is targeted at organisations in a critical position.

Who can apply? Small to medium sized not-for-profit organisations in the UK

Tech for Good Build 2021

Aims/priorities: Grants for not-for-profit organisations to define, test and develop digital solutions, or re-purpose existing technology in order to meet a social need or challenge in one of Comic Relief's

core issue areas. The Covid-19 crisis has since increased the need for organisations to explore how digital and design approaches can be used to create more impact for the people they work with. The funding is most suitable for organisations or partnerships that have undertaken a small amount of early stage discovery work.

Who can apply? UK not-for-profit organisations can apply. To be eligible, applicants must:

- Be based in the UK for the work taking place in the UK
- Have an income of between £75,000 and £10 million
- Partnerships or consortia between multiple not-for-profits that aim to work together to address or improve a service delivery problem in their area of work are welcome to apply

Applications are also welcome that address challenges related to disability and inclusion outside of these themes.

Grant amount: Grants of up to £70,000 per project are available

Volant Charitable Trust – Covid-19 Response Fund

Aims/priorities: The Covid-19 Response Fund aims to help charities in the UK and abroad to alleviate social deprivation, helping vulnerable people affected by the coronavirus pandemic. The activity must be specifically related to the Covid-19 pandemic and can be for project and administrative costs, as the Trust does not usually fund capital expenditure. However, applications for medical equipment and the production or distribution of PPE may be considered.

Who can apply? Registered charities, community interest companies, community organisations and social enterprises based and working in the UK (or abroad) may apply.

Grant amount: Funding is at the discretion of the Trustees

Application process: There is an online application form

Youth Covid-19 Support Fund



Aims/priorities: The fund will focus on enabling the struggling, but most impactful, youth organisations in England to continue operating, where they may have scaled back service provision or temporarily closed due to reductions in their income as a result of the Covid-19 pandemic. Grants are available for costs incurred between 1 November 2020 and 31 March 2021 that enable the organisation to remain viable, open, reopen or partially reopen, where this represents a value for money approach and where their service delivery is in line with Government Covid-19 guidance. The funding can be applied retrospectively to eligible expenses already incurred during this period that have not been funded by another external source. Funding is intended to cover essential business expenditure, such as staff salaries, and fixed/operational costs.

Who can apply? Applications will be accepted from grassroots youth clubs, uniformed youth groups, and national youth and umbrella organisations based in England. Applicants must be one of the following:

- A registered charity
- An incorporated not-for-profit organisation
- An incorporated Community Interest Company

Grant amount: The following maximum levels of support are available:

- Local organisations may request funding of up to whichever is the lower of 25% of their annual income, or Deficit from November 2020 to March 2021*; or £250,000
- National organisations may request funding of up to whichever is the lower of 25% of their annual income, or Deficit from November 2020 to March 2021*; or £2 million

**The deficit which can be funded must account for any other funding received (that is, DCMS can only fund any remaining deficit). This funding should not be used to increase reserves above the level at 31 October 2020. All grants must be spent by 31 March 2021.*

The Charity Service Grant Fund

Aims/priorities: Financial support in the form of grants is available to registered charities, CIC's and voluntary organisations. The Charity Service are keen to support organisations that are working 'on the



ground' directly supporting disadvantaged people within the Greater Manchester area. Grant funds are available for:

- the purchase or supply of activities, amenities or equipment that will improve the general welfare of the local community or an individual
- the purchase or supply of activities, amenities or items of a medical nature NOT supplied by the NHS
- new project costs (for a specific period)
- any other charitable purpose that has a direct impact on the welfare of the local community or an individual
- holidays or days out to visit an attraction for children who are disadvantaged, disabled, sick and/or convalescent whose family are unable to afford the cost (referral must be via a supporting agency)

Who can apply? Registered charities, CIC's and voluntary organisations

Grant amount: Grants applications for funding will be assessed on the proposed impact, outcomes and budgetary detail. Grants applications of £5,000 or more (up to a maximum of £10,000) will require a greater level of scrutiny at the application stage and, if successful, monitoring by The Charity Service will be required.

David Wilson Homes North West – Our Space Your Place Grants



Aims/priorities: Provided by housebuilding company David Wilson Homes North West, the Our Space Your Place grant scheme is an initiative that offers a small amount of funding each year to help improve and enhance local communities in the North West of England. Eligible projects could include providing a charitable service, enhancing the local environment or offering educational facilities.

Who can apply? Any companies and organisations, including community groups and charities, that are based in Cheshire, Greater Manchester, Staffordshire, Merseyside, Flintshire, Wrexham and Lancashire. To be eligible, applicants must:

- Have a bank or building society account
- Be able to use the grant within four months of receiving it
- Be willing to take part in any media or press activities that may take place

- Have their registered office address or place of business in the North West of England.

Strategic Legal Fund for Vulnerable Young Migrants



Aims/priorities: The fund supports legal work to promote the rights of vulnerable migrant children and young adults. The grants are for strategic legal work where the impact is likely to go beyond an individual case, and result in changes to law, policy and practice that benefit a wider group of people. The Strategic Legal Fund (SLF) funds strategic legal work in any area of law where vulnerable young migrants experience disadvantage or discrimination as a result of migration status. The SLF defines vulnerable young migrants as follows:

- Migrants or the children of migrants
- Who are under 25 years
- Who are living in poverty

- Who face significant disadvantage or discrimination in connection with their (or their parents') migration status

The funding is for strategic legal work which is defined here as work where the impact is likely to go beyond an individual case, and to result in changes to law, policy and practice that will benefit a wider group of people. Applications must be to fund one of two kinds of strategic legal work:

- The research and development of cases pre-litigation including: gathering evidence to test a hypothesis or research to establish authorities' policy and practice, identifying potential plaintiffs/applicants/appellants; researching whether to proceed; translating relevant material; and evaluating a litigation strategy
- Third party "interventions" in existing cases, which allow a non-party intervener to assist the court in arriving in its decision in a case, acting as an amicus curiae, a friend of the court

Applicants should check the list of previous SLF grants to make sure their proposal does not duplicate any existing work.

Get Fishing Fund – Angling Trust

Aims/priorities: Following a period of lockdown in England, due to the coronavirus outbreak, an increase in the popularity of angling was observed, with nearly a million people buying or renewing a fishing licence since the spring. As a means of



encouraging the wellbeing benefits the sport can offer, the Get Fishing Fund has been established to encourage more people in England to take up fishing or get back into angling.

Who can apply? Applications are accepted from angling clubs, fisheries, charities, schools and local authorities in England that want to increase the number of people being introduced to angling. Activity that is delivered as a result of receiving funding must be delivered on freshwater fisheries where angling requires a fishing licence.

Grant amount: Organisations can apply for up to:

- £500 towards small projects to assist them in delivering events and coaching activities
- £5,000 for large projects

Leslie Sell Charitable Trust

Aims/priorities: The Leslie Sell Charitable Trust provides grants for organisations belonging to the Scouting or Guide movement in the UK.

The Trust makes small grants to Groups to help with the cost of making repairs, or purchasing sundry items of equipment. It also gives assistance to groups and individuals when they make trips in the UK or overseas. Due to the current pandemic and the disruption this has caused to normal Scouting and Guiding activities the Trust is introducing two additional grants. One will be for IT support (e.g. towards a zoom membership for one year or the purchasing of fire sticks or similar) to assist with delivering a blended Scout or Guide programme. The grant amount for this category would be £100. The second grant would be to help with the Census/Insurance costs for 2021 due to falling subscription payments and lack of other fundraising opportunities in 2020. The amount of this grant would be 75% of the Group annual charge up to a maximum of £750. These new grants will be reviewed in May 2021.



Who can apply? Eligible organisations must be part of the Scouts or Guides associations.

Grant amount: Funding is at the discretion of the Trust. As a result of the coronavirus pandemic, the Trust has introduced two additional temporary grants:

- IT support: £100 to assist with delivering a blended Scout or Guide programme.
- Census/insurance costs for 2021: up to £750 is available to cover 75% of the Group's annual charge.

Return To Play Fund

Aims/priorities: Sport England have launched a new £16.5 million fund to provide additional help to the sport and physical activity sector during the coronavirus (Covid-19) pandemic.



The Return to Play Fund will support groups, clubs and organisations who've been impacted by restrictions brought in to tackle the disease, and is part of our overall response to the crisis that now includes more than £220m of government and National Lottery funding.

The fund will especially seek to support those groups and organisations working with audiences identified as finding it more difficult to be active at this time. These include:

- Black, Asian and minority ethnic communities
- people on lower incomes
- those disproportionately affected financially as a result of the crisis
- disabled people and people with long-term health conditions
- those who are experiencing a greater burden of care responsibilities since the pandemic began

Who can apply? Your organisation can apply if you're:

- a not-for-profit voluntary group or sports club
- a not-for-profit community club or organisation
- a registered charity
- a not-for-profit company
- a community interest company (CIC) or other social enterprise

Grant amount: Three grant types are available, for applications between £300 and £10,000; £10,000 to £50,000; and for matching crowd funded income of up to £10,000.
