VCSE organisations working outside of the City of Manchester, consultants, sole traders, statutory bodies, private businesses and infrastructure organisations who become members of Macc aren't eligible to access our funding portal. #### Allchurches Trust – Hope Beyond

Aims/priorities: The aim of the Hope Beyond grants programme is to enable churches and Christian charities to meet changing needs within their

communities as the longer-term impact of the coronavirus/Covid-19 crisis becomes clearer. The funding is for innovative, impactful projects that will enable people, organisations and communities to flourish in life after lockdown, building resilience and encouraging hope. Projects that address at least one of the following three key themes are eligible:

- Projects responding to the issues of loneliness and isolation exacerbated by the coronavirus/Covid-19 pandemic where new and/or enhanced support is being proposed. This could include enabling improved accessibility to buildings/activities and measures to ensure buildings are coronavirus/Covid-19 safe
- Projects focused on growing community resilience and promoting mental and emotional health and wellbeing, including the provision of mental health and wellbeing support groups and 1:1 counselling for people of all ages
- Projects focused on growing technological capability and resilience, particularly increasing digital capacity and provision, and supporting those without online access to get online through training and support

Who can apply? Churches, cathedrals, Christian denominational bodies and Christian charities

Grant amount: Grants of up to £50,000 are available

Application process: There is an online application form

**Deadline:** Applications will be accepted on a rolling basis until all the funding has been allocated

#### Alpkit – Go Nice Places, Do Good Things Grant

**Aims/priorities:** Alpkit welcome any applications from individuals or organisations serving those affected by coronavirus, across the country. Examples include:

- Being active in your local community to help elderly or vulnerable people
- Minimising the impact of self-isolation for those in quarantine and need access to food, medicines or social care





- Supporting foodbanks and increasing the number of meals on wheels deliveries to support the elderly

#### Arts Council England National Lottery Projects Grants

**Aims/priorities:** In response to the impact of the coronavirus/Covid-19 crisis on the sector, between July 2020 and April 2021 the programme will support individuals and organisations to get activities up and running



again, and to help people take their first steps in getting re-engaged with culture and creativity.

**Who can apply?** Because of the circumstances during the coronavirus/Covid-19 crisis, the programme will be particularly keen to support:

- Applications from individual creative practitioners (including time to think and plan)
- Research and development activity
- Organisational development activity
- Live activity that can be safely delivered within this period (rather than activity with a start date far in the future)
- Activity that closely aligns with the Arts Council's Equality Objectives

Grant amount: Maximum Value: £ 100,000 - Minimum Value: £ 1,000

Grants can support projects where the capital-specific expenditure in a project totals less than £100,000. This includes:

- Applications for capital work only, where that capital work will cost up to £100,000
- Applications for a mix of activities that include some capital spending where the total cost of the capital work is less than £100,000

#### **BBC Children in Need Main Grant and Small Grant Applications**

**Aims/priorities:** All applications will have to show how this funding will make a difference to children and young people's lives during this crisis. Due to the COVID-19 pandemic, the

funder has temporarily broadened the types of applications it is accepting. Currently funding

is being offered that can be used more flexibly than usual. Applications are encouraged for:

- Project delivery (Including staffing and salary costs)
- Creative solutions to deliver much needed services
- Organisational costs to support stability and adaptation. (Including the day-to-day running costs of an organisation as opposed to specific project costs)

Applications are not limited to one specific project and a request can be made for organisational running costs. The funder is committed to supporting voluntary groups with these types of grants.

**Who can apply?** Registered not-for-profit organisations that work with disadvantaged children and young people of 18 years and under who live in the UK, the Isle of Man or the Channel Islands.

**Grant amount:** Small grants: up to £10,000. Main grants: £10,001 - £40,000 per year for up to 3 years (but rarely more than £100,000 in total).

**Application process:** The application process requires that applicants register by submitting an Organisation Registration form. Once registered, organisations will receive a link to fill in a Main Grants Project Application Form. This form can then be accessed through the online application portal. Registration is open all year-round, with cut-off dates for each application round. It is expected that decisions on Registration will take about three weeks.

### **Community Business Renewal Fund by Power to**



#### Aims/priorities: The fund provides grants of between

£10,000 and £20,000 to community businesses in England affected by the Covid-19 crisis to adapt, renew and rebuild their business so they can remain financially viable. The fund is aimed at organisations delivering services in their local community to support those who have been most affected by the Covid-19 crisis. The main priority support areas for the fund include: areas of England facing high levels of deprivation, organisations supporting and led

by disabled people and Black, Asian and Minority Ethnic (BAME)-led or BAME-supporting businesses.

Who can apply? Community businesses

#### LGBT+ Futures Fund



**Aims/priorities:** The aim of the Fund is to provide funding for

LGBT+ organisations and projects to enable them to continue through the coronavirus/Covid-19 pandemic and meet the immediate needs of LGBT+ people and communities adversely affected by the pandemic. Grants will be awarded towards ongoing work, core costs and additional work which strengthens the position of organisations and their ability to respond to community needs at this challenging time. Grants are for short-term work only and all funds awarded must be fully spent by 31 May 2021.

Who can apply? UK based non-profit groups and organisations that work with Lesbian,

Gay, Bisexual and Trans + (LGBT+) people can apply.

Grant amount: Two levels of funding are available:

- Small grants of up to £5,000
- Main grants of between £5,001 and £15,000. Most grants will be for between £5,001 and £10,000 and larger grants will be exceptional

Each organisation can apply for one grant only - either a small or a main grant.

**Application process:** The guidance notes and application forms can be found on the website of the Consortium. The funding will be awarded in tranches to ensure enough funding is carried forward to meet the needs of later applicants. Organisations will receive a decision within six weeks of receipt of application.

Aims/priorities: The aim of the grants programme is to support

- Help more people to reach their potential, by supporting them at the earliest possible stage

During the ongoing coronavirus/Covid-19 pandemic, the Awards for All programme is supporting people and communities most adversely impacted by the crisis. Organisations can apply for funding to:

- Continue to deliver activity whether the community needs crisis response, recovery or business as usual activity
- Change and adapt, becoming more resilient to respond to new and future challenges

**Who can apply?** Applications are accepted from Voluntary, Community and Not for profit organisations, schools (for projects that benefit and involve the communities around the school), Statutory bodies (including local authorities, town, parish and community council) and Community benefit societies. To be eligible for funding applicants must have:

- Two unconnected people on the board or committee
- A UK bank account in the name of their organisation
- Annual accounts (unless the organisation is less than 15 months old)

The National Lottery Community Fund is 'keen' to support smaller organisations and will consider their income when making a decision.

Grant amount: Grants of between £300 and £10,000 are available for up to one year.

#### National Lottery Community Fund – Partnerships



**Aims/priorities:** Grants are available to voluntary and community organisations in England which work together with a shared set of goals and values to help their community thrive. The aim of the programme is to encourage organisations to work in partnership to help their communities thrive by focusing on the bigger picture, rather than just what their organisation can do on its own. "Communities" can be people living in the same area, or people with similar interests or life experiences. The funding can support different types of partnership, including:

- Cross-sector partnerships
- Local place-based collaboration
- Local and national organisations working together around a particular theme

**Who can apply?** Applications are accepted from Voluntary, Community and Not for profit organisations, schools (for projects that benefit and involve the communities around the school), Statutory bodies (including local authorities, town, parish and community council) and Community benefit societies.

Grant amount: Grants of over £10,000 are available for up to five years.

Application process: Funding proposals can be submitted using the online application

form or by sending an email or video to the relevant regional funding officer

**Aims/priorities:** The aim of the grants programme is to support communities to thrive by funding projects that:

- Build strong relationships in and across communities
- Improve the places and spaces that matter to communities
- Help more people to reach their potential, by supporting them at the earliest possible stage

During the ongoing coronavirus/COVID-19 pandemic, the Reaching

Communities programme is supporting people and communities most adversely impacted by the crisis. Organisations can apply for funding to:

- Continue to deliver activity whether the community needs crisis response, recovery or business as usual activity
- Change and adapt, becoming more resilient to respond to new and future challenges

**Who can apply?** Applications are accepted from Voluntary, Community and Not for profit organisations, schools (for projects that benefit and involve the communities around the school), Statutory bodies (including local authorities, town, parish and community council) and Community benefit societies. To be eligible for funding applicants must have:

- Two unconnected people on the board or committee
- A UK bank account in the name of their organisation
- Annual accounts (unless the organisation is less than 15 months old)

Grant amount: Grants of over £10,000 are available for up to five years.

Application process: Funding proposals can be submitted using the online application form on the National Lottery Community Fund website or applicants can send an email or video to their regional funding officer (details are on the National Lottery Community Fund website). Organisations will then be contacted by the National Lottery Community Fund within 12 weeks of submitting a proposal to discuss the next steps of the application process.

#### **Resilience and Recovery Loan Fund**



Aims/priorities: The fund aims to support social-sector

organisations working to improve people's lives in the UK that are

facing a problem because expected income and activity has been delayed or disrupted as a result of the coronavirus/Covid-19 pandemic. The scheme offers emergency loans that can be used as working capital until an organisation's normal business can commence again. Examples of how the loan funding could be used include:

- Providing a bridge until receiving government payments (e.g. contracts, furlough etc.)
- Covering a delay in trade payments (trade debtors)
- Supporting the rapid scaling up of an existing business model to meet an increased demand for services during the crisis

• Providing a bridge to cover revenue shortfall for proven and profitable trading activity **Who can apply?** Applications are accepted from social-sector organisations that are improving people's lives across the UK and that meet the <u>governance principles</u> set out by Big Society Capital.

**Grant amount:** Loans of between £100,000 and £1.5 million are available for a term of one to five years. Loans will have no fees or interest for the first 12 months. After principal

payments start the following interest rates will be applied: 6.5% p/a (from year two) for a loan term of 1-3 years; 7% p/a (from year two) for a loan term of more than 3 up to 5 years. **Application process:** An online application form and guidance documents are available on the SIB website.

Aims/priorities: Financial support in the form of grants is available to registered charities, CIC's and voluntary organisations. The Charity Service are keen to support organisations that are working 'on the ground' directly supporting disadvantaged people within the Greater Manchester area.

Grant funds are available for:

- the purchase or supply of activities, amenities or equipment that will improve the general welfare of the local community or an individual
- the purchase or supply of activities, amenities or items of a medical nature NOT supplied by the NHS
- new project costs (for a specific period)
- any other charitable purpose that has a direct impact on the welfare of the local community or an individual
- holidays or days out to visit an attraction for children who are disadvantaged, disabled, sick and/or convalescent whose family are unable to afford the cost (referral must be via a supporting agency)

Who can apply? Registered charities, CIC's and voluntary organisations

**Grant amount:** Grants applications for funding will be assessed on the proposed impact, outcomes and budgetary detail. Grants applications of  $\pounds$ 5,000 or more (up to a maximum of  $\pounds$ 10,000) will require a greater level of scrutiny at the application stage and, if successful, monitoring by The Charity Service will be required.

**Aims/priorities:** The Manchester Airport Community Trust Fund is a registered charity and was established to promote, enhance, improve and protect both the natural and built environment in the local community. To be successful a group must:


