### Funding available now

#### **AB Charitable Trust**

UK-registered charities that work towards combating abuse and violations of human rights can apply for grants of up to £20,000. Applications are particularly welcomed from charities working to support migrants, refugees and asylum seekers; criminal justice and penal reform; human rights and access to justice. Deadlines: 25 April 2021, 31 July 2021, 31 October 2021. More information [here](#)

#### **AHF Transforming Places Through Heritage Programme \*New 09.04.21 #shortdeadline\***

- Crowdfunding Challenge Grants: up to £25,000, to match fund crowdfunding campaigns



- Project Viability Grants: up to £15,000, for early viability and feasibility work
- Project Development Grants: up to £100,000, for capital project development costs
- Transformational Project Grants: up to £350,000, for transformational capital projects
- Community Shares Booster Grants: development grants up to £10,000 and equity investments up to £50,000 for Community Benefit Societies and Cooperatives. This grant programme is being managed by Co-Operatives UK on behalf of AHF

### **The Allan and Nesta Ferguson Charitable Trust #2021**

The Trust is accepting applications in response to the current pandemic and for projects looking to deliver longer terms results. Themes include education, international friendship and understanding, and the promotion of world peace and development. Applicants must be registered as a charity with the UK Charity Commission. Alpkit welcome any applications from individuals or organisations serving those affected by coronavirus, across the country. Examples include:

### **Arts Council National Lottery project grants**

The Arts Council National Lottery Project grants has reopened for applications for grants of £1,000 to £100,000 for arts, museums and libraries projects. The Ashworth Charitable Trust is a small grant-making charity to support humanitarian causes operating locally, nationally and internationally, as opposed to animal or utilitarian projects. ### **Betty Messenger Charitable Foundation**

Small grants of between £100-£1,000 are available to registered charities with an annual income of under £1million. ### **Big Society Capital**

Additional routes to loans for social enterprises and charities. Initially for the first year on a no fee, no interest basis. Resilience and Recovery Loan Fund. Managed by Social Investment Business (SIB), to enable social lenders to provide emergency loans to affected social enterprises and charities without requiring personal guarantees and charging no fees or interest for 12 months. Smaller emergency loans will also be made available to smaller organisations in deprived areas. More information [here](#)

### **Black Training and Enterprise Group (BTEG) – Covid-19 Response Capacity Building Project**

BTEG is offering capacity building support for BAME organisations with an income less than £150,000 that have been directly impacted by the virus so that they can ‘think differently and act strategically’. Groups will have up to 3.5 hours of free expert consultancy support and/or coaching specific to their organisational needs, as well as access to up to 20 organisational and leadership development workshops. ### **BlueSpark Foundation**



The BlueSpark Foundation's objective is to fund or part-fund projects that aim to improve the education and development of children and young people by means of educational, cultural, sporting or other activities. The funding is for relatively small-scale projects, which might not happen at all or would only happen on a lesser scale without the support of BlueSpark. Grants of up to £5,000. ### **The Boost Choose Now Change Lives programme**

Community grants of up to £20,000 to support a range of community groups and organisations, including: sports clubs, community action groups, youth work, music groups and food banks. The initiative is open throughout 2021. More information [here](#)

### **Central Social and Recreational Trust \*New 09.04.21\***

Grants of £1,000 are available for sports clubs and organisations in England to provide or assist in the provision of facilities for recreation or other leisure time occupation for the benefit of disadvantaged children who are under the age of 21 years. ### **The Charity Service Grant Fund**

Applications for funding are invited from registered charities, CICs and voluntary organisations which work with disadvantaged people for any reason, sick, infirm or living in poverty within the Greater Manchester area. Applications are welcomed from all organisations however the priority at the moment is to support organisations that have experience, and a proven track record, of delivering projects dealing with homelessness, reducing social isolation, improving access to employment and providing emergency support to vulnerable families/children. Grants applications will be assessed on the community impact, sustainability, outcomes and budgetary detail. The average grant award is £1,000, in exceptional circumstances larger grants, up to a maximum of £3,000, may be considered. ### **Charles Hayward Foundation \*New 09.04.21\***

Up to £7,000 grants for Older People's projects that are preventative and early intervention programmes delivered locally that allow older people to stay in their own homes and remain independent. The Foundation is particularly

Currently closed, but re-opening in April. Focused on the needs of specialist social welfare legal advice organisations, grants can be used flexibly to meet the needs of the organisation. Grants from £25,000 to £75,000 depending on

**Discretionary Additional Restrictions Grant Scheme**

The Government has provided an additional discretionary fund to Local Authorities to support businesses that are not eligible for a Local Restrictions Support Grant. You only need to apply once, your application will be assessed



to make sure you receive all of the grant payments you are eligible for. More information [here](#)

### **DPD Eco Fund \*New 09.04.21\***

Anyone can apply for up to £2,000 funding, although they particularly encourage schools and educational facilities across the UK working on green projects with their students and start-up companies working on developing environmentally friendly products to apply. ### **Duchy of Lancaster Benevolent Fund**

Grants of £250 – £1,000 to registered charities. Applications considered quarterly. The Greater Manchester Trustees are interested in:

- Causes with which the Duchy has historical association such as Church livings, Estates etc. and purposes which will benefit the community
- Organisations which provide care and support for the elderly, inform and disadvantaged members of society

### **ESF Community Step Ahead Grants Round \*New 09.04.21 #shortdeadline \***

The Step Ahead round seeks applications from a wide range of voluntary organisations who are ready to reach out by using approaches which tackle the new and emerging barriers arising from the impact of Covid-19, working both remotely and within social distancing requirements, once restrictions are eased. Small grants of up to £20,000 are available across Greater Manchester to eligible organisations in the VCSE sector. Projects should look to develop and maintain participant connections to learning experiences. Project activity should support, maintain and improve participant employability and resilience. Activities should develop progression routes into employment, Further Education and training for participants. All project activity must be within the current government Covid-19 restrictions, but should include flexibility to adapt as and when those restrictions change in future months. ### **Expanded Additional Restrictions Grant**

Grants for businesses in Manchester with Business Rates liability or fixed property costs who have been significantly impacted Self- employed company director or sole trader of a small business without fixed business property related costs in hospitality, entertainment, leisure and culture sectors. ### **The Fair Education Alliance Innovation Award 2021**

This is a year-long programme of support including a £15,000 salary contribution for up to five individuals working to make education fair. The Alliance is looking for applicants with any background, who have a great idea to improve the education system. ### **The Fat Beehive Foundation**

### **The FCC Community Action Fund**

Grants of between £2,000 and £100,000 to not-for-profit organisations for amenity projects eligible under Object D of the Landfill Communities Fund (LCF). Only applications for projects sited within 10 miles of an eligible FCC Environment waste facility can be accepted. Deadlines: Round 2 opens on 17 March 2021 and closes on 2 June 2021, 5pm. Round 3 opens on 16 June 2021 and closes on 1 September 2021, 5pm. Round 4 opens on 15 September 2021 and closes on 1 December 2021, 5pm. More information [here](#)

### **The Fore**

From Spring 2021, The Fore is returning to its standard offer of grants of up to £30,000, which can be spread over up to 3 years. They make unrestricted grants which have the potential to have a transformational impact on an organisation, including helping organisations become more sustainable, more efficient, to grow significantly or enabling an organisation to take a major step forward of some kind. The Fore is particularly looking to fund small organisations working with marginalised groups and led by people in the community that may have found it hard to access trust and foundation funding in the past. Any registered charity, CIC, CIO or Community Benefit Society with turnover of under £500,000 in the last financial year is eligible to apply. More information [here](#)

### **Football Foundation – Grass Pitch Maintenance Fund \*New 09.04.21\***

Grants of up to £2,500 are available for grassroots football organisations in England to sustain football pitches already at a 'good' level and to enhance pitches that are either considered 'poor' or 'basic'. Ongoing deadlines. More information [here](#)

### **Forever Manchester and Kellogg's Breakfast Club Grants Programme**

Grants of up to £1,000 to schools in the UK to set up Breakfast clubs for those children in most need. Priority will be given to schools that have 35% and above of children eligible for pupil premium funding and / or eligible for free school meals or that are based in an area which is classified as falling in the 10% of most deprived areas according to the Index of Multiple Deprivation. ### **The Foyle Foundation – Small Grants Fund #2021 #core**

Registered charities with an annual income of no more than £150,000 can apply for grants of up to £10,000 towards core costs or essential equipment to enable ongoing service provision, homeworking, or delivery of online digital services. More information [here](#)

### **Future Workforce Fund Grants Programme**

Grants to support pilot programmes of work with young people (up to age 25) across Greater Manchester city region facing barriers to engagement with education, employment or training. Grants up to £25,000 available. More information [here](#)

### **GMCVO Emergency Investment Fund**

Loans available for Social Enterprises, Charities and Community Businesses who are in urgent need of capital caused by Covid-19. This Emergency Investment Fund helps organisations by providing loans ranging from £50,000 to £250,000. There is a repayment and interest free period of up to 2 years at the start of the investment and then a 3 year repayment period. Deadline extended to: 16 May 2021. More information [here](#)

Funds up to £1,000 available to invest in local groups or neighbourhood activities, for example planning community meetings, purchase much needed equipment for youth engagement or to assist in transforming your street, local community projects and any other projects in the community. ### **Greater Manchester Technology Fund**

Launched by Andy Burnham, the Technology Fund aims to provide learners at risk of digital isolation with a ‘digital kit bundle’: the technology and connectivity needed to continue their learning at home while schools and colleges remain closed. Register your school’s or college’s requirements or find more information [here](#)

### **The Hedley Foundation**

Grants of up to £5,000 to smaller charities operating across the spectrum of social need including improving lives and lifting people’s aspirations. Deadline: 30 June 2021. More information [here](#)

### **Help the Homeless**

Grants up to £5,000 with projects that assist individuals in their return to mainstream society, rather than simply offering shelter or other forms of



sustenance. Applicable only to small and medium-sized charities with an annual turnover of under £1m. Deadlines: 15 June 2021 / 15 September 2021 / 15 December 2021. More information [here](#)

### **The Henry Smith Charity – Christian Projects \*New 09.04.21\***

A minimum £10,000 funding for up to 3 years is available for projects that address at least one of the fund's three priorities:

- Meeting the spiritual needs of older people, including those with dementia
- Reaching out to the unchurched – especially young people and young families – by nurturing spiritual interest and wellbeing
- Projects that support and care for Anglican clergy at times of acute need.

### **Henry Smith – Improving Lives Programme #core**

The Improving Lives large grants programme awards £20,000 – £60,000 per year for up to 3 years to charitable organisations that help people when other sources of support have failed, are inappropriate, or are simply not available. Support to registered charities providing opportunities for disadvantaged children and young people, under the age of 25, to fulfil their potential. **Joseph Rowntree Charitable Trust – Rights and Justice Programme \*New 09.04.21\***

Discretionary grants for individuals and VSCE groups for:

- Protection and promotion of equality and human rights and their enforcement in the UK
- Promoting rights and justice for minorities who face the most severe forms of racism
- Promotion of rights and justice for refugees and other migrants by identifying and tackling structures and systems that may deny them their rights
- Responding to the dual harms of Covid-19 and systemic racism
