

My COVID-19 Self-Assessment

Salford CVS are committed to ensuring that our team of staff and volunteers are as safe as possible on return to the workplace / external activities.

As you will be aware from the media, some people are more at risk of harm from Covid-19 than others and we would like to ensure that we know if we need to put any additional measures in place for any of our staff and volunteers to ensure that they are safe as possible. So, we are asking you to complete a short self–assessment form that will help to manage your return to the workplace / external activities.

This form has been adapted from the NHS Salford CCG and Salford City Council 'Individual Risk Assessment Toolkit'.

This self-assessment will help us to **protect you**, **your family or household and the CVS team**. The information given by you will be treated as confidential and will not be used for any other purpose than assessing what we need to do to keep you safe. Completing this form is optional, but you will need to tell us formally (in writing) if you do not wish to complete.

Assessor Guide

Please add the scores from all the lines.

Significant (High) Risk: please complete an Individual Risk Assessment where

- A score of 13 or more indicates a significant risk
- A BMI of 40+
- Where an individual says that they have been told by a health professional that they are 'clinically extremely vulnerable'* to Covid-19
- They are over 28 weeks pregnant
- Offer free Health Check (see below)

Smokers should be considered to have a moderate risk.

Moderate risk i.e. a score between 9 and 12, you should consider completing an individual Risk Assessment.

Assessors should check Government Guidance regularly as this changes frequently.

<u>All staff</u> should be made aware of Salford free Health Checks for key workers, which includes Salford CVS staff.

The checks take around 20 mins and are bookable through the Spirit of Salford helpline 0800 952 1000 (option 2). Staff may complete these during the working day.
