

Find the funding that you need

Our funding search engine is a straight forward FREE service using information from IDOX Information Solutions that can help voluntary, community, social enterprise sector organisations like yours to find suitable funding.

By becoming a member of Macc you will gain access to our free funding portal of funding opportunities. Please note: To be

eligible to access our funding portal you must be a voluntary, community, social enterprise sector (VCSE) organisations working in the City of Manchester with at least 50% of your beneficiaries in



the City of Manchester. VCSE organisations working outside of the City of Manchester, consultants, sole traders, statutory bodies, private businesses and infrastructure organisations who become members of Macc aren't eligible to access our funding portal.

Neighbourhood Investment Funds

Aims/priorities: These are funds available to communities to make their neighbourhoods better places to live. £20,000 of neighbourhood investment funding is

available to every area (ward) in Manchester each year - to help groups carry out events and activities that benefit people in their local neighbourhood.

Who can apply: The fund is open to established groups, voluntary groups and other community groups, as well as groups of residents working together for the first time. School Parent Teacher Associations can also apply if they have the support of local residents and parents and the project benefits the wider community as well as the school.

Grant amount: Applications should not exceed £10,000

Application process: Online application form

Deadline: Ongoing, apply at any time

Aims/priorities: Grants are not normally made for new building work but payments for fitting out of specialist premises may be made. Long term commitments are not usually made but an indication that a grant may be paid, subject to conditions and annual review, for up to three years may be given.

Who can apply: Ordinary Grants: These grants are made for a wide variety of purposes under the general heading of 'social welfare', e.g. to assist people with medical conditions, disabilities,

addictions, to help the aged, youth work etc. Applications for new work are welcome and the Trustees give special consideration for 'pump priming' requests

Grants are to support a wide variety of arts-related activities: Audio-visual, broadcast and transmission, buildings and infrastructure, capacity building, commissioning, digital creation, diversity and equality, education and learning, exhibition, festival, organisational development, original work, participation, performance, production, professional development, publishing, research and development, sector development, talent development, touring. Who can apply? The Open Fund for Organisations

Aims/priorities: The Open Fund for Organisations supports new music projects led by promoters, talent development organisations, venues, curators and large performance groups. Projects must involve the creation,

performance and promotion of new music and enable songwriters, composers, or solo artists, bands, producers and performers of all backgrounds to develop creatively and professionally. Support is available to any organisation whose project fits with all three funding priorities:

- 1. To support the creation, performance and promotion of outstanding new music in any genre - The Fund is particularly interested in the guality of the music
- 2. To enable the UK's most talented music creators to realise their potential The Fund is interested in how your project will develop the songwriters and composers involved.
- 3. To inspire audiences You will be asked to outline who you are reaching and how. This includes audiences at a local, regional, national or international level

Through The Open Fund, high quality new music projects are supported which have tangible musical outcomes and a clearly defined start and end date.

Who can apply? The Open Fund is available to any not-for-profit organisation based in the UK with an eligible project. This includes: Promoters; Festivals; Orchestras and large ensembles; Talent development or composer development organisations; Venues; and Curators Grant amount: Grants of up to £10,000 are available





Application process: The application is a 2 stage process. Only those with successful 1st stage applications will be asked to continue on to the 2nd stage where there will be an opportunity to add new and updated information.

CHILDREN & YOUNG PEOPLE

BBC Children in Need – grants programme

Aims/priorities: The BBC Children in Need grant supports UK charities and not for profit organisations working with disadvantaged children and young people who are 18 years old and under. Small



grants of £10,000 or less per year for up to three years and Main Grants over £10,000 per year for up to three years.

Who can apply? Children in Need give grants for projects delivered by organisations working with disadvantaged children and young people, who must be 18 years and under, living in the UK, the Isle of Man or the Channel Islands.

Disadvantages experienced by children and young people include:

- Illness, distress, abuse or neglect
- Any kind of disability
- Behavioural or psychological difficulties
- Living in poverty or situations of deprivation

The application should focus on the children your project will work with and the differences that your project will make for them. You should clearly be able to demonstrate how your project will change the lives of the children involved for the better. Where possible it should take into account their views and involve them in decisions that affect them.

The Ironmongers' Company

- Are within the UK

Who can apply? Grants are only given to registered charities

Grant amount: Grants range from a few hundred pounds up to around £10,000. The average grant awarded is £4,000

Aims/priorities: The Local Community Projects Fund helps organisations based in local communities to deliver projects or provide

equipment to people in need at the heart of local communities. The Greggs Foundation are interested in projects that improve resilience within your community of interest. This can include sessional activities/respite support, equipment for sessional activities, trips and residential breaks. The Greggs Foundation is also interested in new approaches and innovative ideas as well as sustainable approaches to supporting your community of interest.

Successful applicants should be able to demonstrate improvements against at least one of these Key Performance Targets to be successful for a grant:

- Beneficiaries have decreased social isolation
- Beneficiaries report improved health and wellbeing
- Beneficiaries report improved resilience/coping mechanisms
- Beneficiaries have improved life skills
- Beneficiaries have improved opportunities

Who can apply? Any not for profit organisation can apply, however, larger organisations with a turnover in excess of £300,000 are unlikely to be successful

places for outdoor recreation. The Recreation theme aims to support projects which will benefit people within their free time. Recreation grants are available to support projects which will benefit

people within their free time. Many projects under this theme also have elements of the other three themes within them; Biffa Award tends to receive more applications under this theme than others. Projects which fall within this description will be registered under the ENTRUST category D. Examples of projects that fall under this category are green spaces, woodland walks, nature reserves, play areas, community gardens and sports facilities such as pavilions, and clubhouses. **Who can apply?** Applications will be accepted from not-for-profit organisations in England, Wales and Northern Ireland. To be eligible for funding projects must:

- Be located within five miles of a significant Biffa Group Limited operation or 10 miles of an ٠ active Biffa Landfill site
- Be within 10 miles of a landfill site (not necessarily owned by Biffa Group Limited) in England, Wales and Northern Ireland
- Have a total cost which does not exceed £200,000 including VAT

Grant amount: Grants of £10,000 to £75,000 are available

Bright Ideas Fund

Aims/priorities: The Community



Business Bright Ideas Fund aims to give your community group the support and tools to start setting up your community business. It will also give your group the early stage finance that you need to carry out consultation with local people and feasibility studies to develop a community business idea the community wants and needs.

Who can apply? To be considered for support and funding through

Bright Ideas, you must:

- be a group, an organisation or an association, not an individual
- be based in England
- have an idea for a community business

Grant amount: Bright Ideas will provide successful organisations with:

- Business development support: Between 2 to 15 days of business development support from Locality, Plunkett Foundation, or Co-operatives UK
- Peer to peer networking: The opportunity to learn from existing community businesses, through visits and events
- Grant funding: The opportunity to apply for a grant of up to £20,000 to develop your idea and/or improve your organisation's capability, depending on your needs

Application process: To apply, you need to answer a few questions which will determine whether you are eligible for Bright Ideas. You can find this at:

Community Radio Fund

Aims/priorities: Ofcom has been tasked by the Department for

Culture, Media and Sport (DCMS) with administering the Fund.

DCMS provides up to £400,000 per annum for the Fund. The



Fund has been established to give grants to help fund the core costs of running Ofcom licensed community radio stations. These core functions include:

- fundraising to support the station (e.g. grants, commercial funding)
- management
- administration
- financial management and reporting
- community outreach
- volunteer organisation and support

Who can apply? Grants can only be made to community radio licensees in the UK, who are broadcasting under a community radio licence.

Grants are made for core costs, equipment or project funding to charities which can show that such a grant will make a significant difference to their work.

Who can apply? Applications are welcomed from charities that have an annual turnover of less than £100,000 per annum

Grant amount: One year grants of between £1,000 and £10,000

Imagine Foundation

Aims/priorities: The Imagine Foundation is a grant-making foundation, which aims to support charities and projects that are particularly focused on building community and on empowering participants to reach their potential. **Who can apply?** Small-scale newer charitable projects and organisations - those that are less than 4 years old and with an annual income of less than £200,000

Ministry of Defence Covenant Fund grant



One Stop Carriers for Causes Grants



While focusing on the big changes people go through in their lives, the fund – Helping the Active Stay Active When Life Changes – also has a particular focus on under-represented groups.

That's because Sport England's research shows those in lower socio-economic groups, women, people with a limiting disability and people aged 55 and over are less likely to have a regular active habit and if they are active, tend to drop out more.

So Sport England want to work with, invest in and learn from partners to better understand what can be done to help active people stay active for as long as they want to, whatever happens in their lives – Sport England are looking for innovative and bold ideas.
