the City of Manchester. VCSE organisations working outside of the City of Manchester, consultants, sole traders, statutory bodies, private businesses and infrastructure organisations who become members of Macc aren't eligible to access our funding portal.

Fourteen £1k Awards

Aims/priorities: Fourteen is a £3.5m national programme funded by Spirit of 2012, a charity set up by the Big Lottery Fund to connect events to communities across the country; supporting opportunities in sport, physical activity, culture and the arts, volunteering and social action. Forever Manchester is the local partner responsible for managing the



money and Harpurhey and Moston is the beneficiary area for the funding. The programme will seek to increase participation in the community through social action and volunteering. Fourteen also seeks to increase inclusion, particularly for young people and people with disabilities.

Neighbourhood Investment Funds

Aims/priorities: These are funds available to communities to make their neighbourhoods better places to live. £20,000 of neighbourhood investment funding is



available to every area (ward) in Manchester each year – to help groups carry out events and activities that benefit people in their local neighbourhood.

Who can apply? The fund is open to established groups, voluntary groups and other community groups, as well as groups of residents working together for the first time. School Parent Teacher

Associations can also apply if they have the support of local residents and parents and the project benefits the wider community as well as the school.

Grant amount: Applications should not exceed £10,000

DM Thomas Foundation for Young People – Central Grants

Aims/priorities: The DM Thomas Foundation for Young People is committed to helping disadvantaged and vulnerable young people and children. The Foundation does this by supporting positive life-changing and life-enhancing activities that improve their health and education. Applications working in the



areas of education or health with one of our four chosen focus groups are selected or considered:

- Children and young people with disabilities
- Children and young people who are sick in hospital
- Employability and training programmes for disadvantaged young people
- Children and young people who are life limited (requiring palliative care)

Who can apply? Applications will be accepted from registered charities in the UK and Ireland **Grant amount:** There is approximately £200,000 available to distribute each quarter. Grants up to £30,000 are available

The Ernest Cook Trust

Aims/priorities: The Ernest Cook Trust gives grants to organisations wishing to encourage young people's interest either in the countryside and the environment, the arts (in the broadest sense), or in science, or aiming to raise levels of literacy and numeracy. Since the ECT is a land-based Trust, work which encourages or ensures the continuation of rural skills and crafts is of



particular interest to the Trustees. All applications are expected to link in with either the National Curriculum or with recognised qualifications. The small grants programme supports state schools and small registered charities which would like to undertake projects which meet the Trust's objectives and require a small amount of pump-priming in order for such projects to take place. The large grants programme is aimed at more comprehensive education programmes: these sometimes require support for the salary of an education officer; in such cases the ECT would always expect to be a part-funder.

Who can apply? All applicant organisations must be based and working in the UK and should be either state schools, registered charities or other recognised not-for-profit organisations.

Grant amount: A large grants programme for awards of over £4,000 and a small grants programme for awards of under £4,000 operate throughout the year

Application process: There are no application forms. All applicants are asked to post a covering letter on the official headed paper of the applicant organisation. 

Aviva Community Fund

Aims/priorities: Projects should make a difference to the community in one of the following four categories: Health and Wellbeing, Skills for Life, Community support, Inclusivity

Who can apply? Community organisations and Charities

Grant amount: There are 4 categories of funding: Up to £1000; Up to £5000; Up to £10,000;

Joseph Rowntree Charitable Trust

Aims/priorities: The Joseph Rowntree Charitable Trust is interested in funding work which is about removing problems through radical solutions, and not simply about making problems easier to live. Generally, the Trust funds work that is about addressing the root causes of problems rather than delivering services or alleviating immediate needs and recognises that change can take many years to achieve.



Applications are currently being accepted under the following priority areas:

- 1. Peace and Security to support a transition towards:
 - The use of 'soft', rather than 'hard' power as a first line of response to conflict within society and around the world
 - The de-legitimisation of violence as a tool for responding to conflict, securing interests or projecting power
 - A culture of human rights and non-violent problem-solving, promoted at all levels of society
- 2. Power and Accountability to support people to create a world in which power is more equally shared, and in which powerful institutions are responsive and accountable to wider society and aligned with the long-term public interest
- 3. Rights and Justice to promote racial justice and equality of opportunity as a basis for a harmonious multi-racial, multi-ethnic society in the UK
- 4. Sustainable Future to develop and promote sustainable, low-carbon alternatives to the current consumerist and growth-based paradigm
- 5. Northern Ireland to fund work which will contribute as a strategic level to the ongoing transformation of the Northern Ireland conflict

Who can apply? The Trust makes grants to a range of organisations and to individuals. It is not necessary to be a registered charity to apply to the Trust. However, the Trust can only support work which is legally charitable as defined in UK law.

Local postcodes should be ranked within the bottom 50% of the latest Indices of Multiple Deprivation. Your communitymust be based in a remote, rural, economically deprived area where there are few local facilities, transport may be anissue, incomes are low and there are limited opportunities for fundraising. 'Urban' is classified as areas with a population of morethan 10,000. The focus is on projects based or working inareas of extreme urban deprivation where local postcodes are ranked within the bottom 20% of the latest Indices of Multiple Deprivation. Within the overarching themes, the Foundation is interested in projects which fall roughly into three categories: Community Support; Arts, Education and Heritage; Disability and Healthcare.

Who can apply? Local or national charities or not-for-profit organisations

Grant amount: Small grants (revenue projects) – grants below £6,000 for revenue costs such as core costs, salaries, overheads, project costs.Small grants (capital projects) – grants below £6,000 for one-off capital costs for new buildings, repairs and improvements, purchase of equipment.Standard grants - grants between £6,001 and £12,000 for revenue or one-off capital costs. Large grants – grants of over £10,000 and up to £45,000 for one-off capital costs only.

Tesco Bags of Help

Aims/priorities: Bags of Help will fund projects that deliver a physical environmental improvement or encourage the use and long term sustainability of outdoor spaces.



Who can apply? Grants will be awarded to voluntary or community organisations (including registered charities/companies), schools, health bodies (eg Clinical Commissioning Groups (CCGs), NHS Hospital Trust, Foundation Trust), Parish/Town Councils and local authorities, social housing providers.

Grant amount: Three local community projects will be votedon in Tesco stores each month across Tesco regions throughout England, Scotland and Wales. In each region, the project that received the most votes from all stores in their region will receive a grant of up to £5,000. The second placed project receives up to £2,000 and third placed up to £1000. Every year, over 7000 projects will receive funding through this scheme.

Who can apply? Small and medium-sized charitable organisations with a turnover of under £1m per annum

Lloyds Bank Foundation – Enable grants

Aims/priorities: Enable grants are awarded to charities which have identified clear development needs, and provide a great opportunity to



strengthen charities to deliver more effectively. Enable grant applicants must identify specific organisational development, have a clear plan of activities and an idea of what they hope to achieve. As a result of their grant funding, they must meet one or more of the five outcomes:

1. Improved activities and services

- 2. Improved leadership/governance
- 3. Improved strategic planning/policy
- 4. Improved structures/systems
- 5. Improved communications

Who can apply? Enable grants are awarded to charities which have identified clear development needs, and provide a great opportunity to strengthen charities to deliver more effectively.

Grant amount: Enable grants are up to a total of £15,000 over one or two years

Deadline: Applications for Enable grants are accepted on an ongoing basis, and applicants will be informed of the outcome of their application within six months of the application being received.

Awards for All – Updated Programme

Priorities/details: National Lottery Awards for All now has three funding priorities. Your project or activity must do at least one of the following:



- bring people together and build strong relationships in and across communities
- improve the places and spaces that matter to communities
- enable more people to fulfil their potential by working to address issues at the earliest possible stage.

It's important to us that you involve your community in the design, development and delivery of the activities you're planning. We feel that your project or activity will be more successful as a result.

They now fund running costs as well as project costs

Who can apply? Community groups, not for profit organisations, statutory bodies or school. You do not need to be a registered charity to apply. Prioritisation is given to groups with lower incomes.

Grant amount: Small Lottery grants of between £300 and £10,000

Deadline: Rolling, apply at least 3-4 months before you want your project to start.

Royal British Legion's External Grants

Aims/priorities: The External Grants programme accepts applications from organisations running, or planning, charitable activities in support of the Armed Forces community. It is intended to fund specialised projects or services for serving and/or ex-Service personnel and/or their families that are not already being provided by The Royal British Legion (the Legion) and that are in line with their programme's Funding Priorities.



Funding Priorities:

- Employment and training
- Support for families
- Supporting the elderly
- Homelessness and outreach

Who can apply? You must be a charitable organisation operating for at least two years and you must share their aims and objectives and be able to:

- demonstrate that the money we give you will directly benefit serving and/or ex Service personnel and/or their families;
- demonstrate that you have attempted to secure funding from other sources (whether you were successful or not);
- demonstrate that your charitable organisation is run efficiently;
- provide evidence to show that there is demand for the project or service and how your project fits with our aims and objectives;
- describe the impact (project outcomes) your project will achieve for serving and/or ex-Service personnel and/or their families, providing evidence where you can

Grant amount: The typical grant award is not likely to exceed £50,000 – smaller applications are encouraged

Application process: There is a two stage application process. The first stage requires a short expression of interest from the applying organisation via submission of a completed Stage One Application Form. Stage One applications will typically be considered within one month of the submission deadline. Successful applicants will be notified and invited to Stage Two.
